Jade works with government agencies, not-for-profits and citizens to co-design, communicate and evaluate social policies, regulatory systems and programs. Jade is passionate about ensuring citizens have a voice in shaping the policies that affect their lives, translating research into real world contexts, and ensuring evaluations are useful and used. Her communications work draws on her experience as a creative writer, time in the publishing industry and design studies.

DISABILITY

- » **National Disability Insurance Scheme (NDIS) Quality and Safeguards system** (Commonwealth Department of Social Services [DSS], 2015–16, 2018, 2019, 2022): Initially, coordinated consultations and Commonwealth–State workshops to develop the Framework and edited the Framework. Subsequently, facilitated revisions to the NDIS Code of Conduct, provided project oversight for auditor training and supported the development of Terms of Reference for the Framework review.
- » **2016 and 2021 Evaluations of the Modified Wage System Trial in Australian Disability Enterprises** (DSS, 2016 and 2021): 2016 and 2020-2: Jade led the design and delivery of both the 2016 and 2021-22 trials of modified versions of the supported wage system in ADEs, which resulted from a Fair Work Commission conciliation process. This included designing participant selection, gaining formal ethics approval, collecting feedback from supported employees, staff, employers and wage assessors, and overseeing the analysis of wage data using the new approach. The recent trial informed the Fair Work Commission's decision about the supported employment award.

ORGANISATIONAL FRAMEWORKS

Jade has worked collaboratively with various NGOs and government agencies to design organisational, monitoring, performance and evaluation frameworks. Jade draws on various approaches including logic models, results based accountability and balanced score cards to develop tailored approaches that support organisations to track how they are going, make improvements and communicate their value.

MENTAL HEALTH AND SUICIDE PREVENTION

- » **Evaluation of Suicide Prevention Initiatives** (NSW Government, 2023): leading ARTD's work in collaboration with Taylor Fry and lived experience researchers to evaluate six programs within NSW's Towards Zero initiative.
- » **Mental Health Lived Experience Workforce Survey** (Department of Health Victoria, 2023): Leading the ARTD team in partnership with Taylor Fry to gather information to develop a comprehensive understanding of the experiences of lived experience workers and organisational attitudes in Victorian mental health services. Analysis of the data and information collected will deliver a baseline which will then be used to develop appropriate benchmarks which can then inform ongoing accountability mechanisms for the sector.
- » **Independent evaluation of Beyond Blue** (Beyond Blue, 2023): Leading the evaluation of the organisation's external activities, to enable Beyond Blue to learn from what is working and what can be improved. The evaluation focuses on impact, value for money, reach and ecosystem, and takes a contribution analysis approach.



Evaluation has immense potential to support the public good. For this to be realised, we need to harness the value of diverse perspectives, focus on the process as much as the product, and be agile – fit in with decision-making cycles and consciously transform our practice in a rapidly changing world.
