- Families capacity building project evaluation (eSafety Commissioner, 2023-2024): Tuli supported the co-design of a program logic, the development of theories of change and a monitoring and evaluation framework for a capacity building initiative within the Office of the eSafety Commissioner. This initiative aims to reduce the risk, extent and impact of online child sexual abuse and exploitation.
- Consultation on Disaster Mental Health Implementation (National Emergency Management Agency, 2023-2024): ARTD was engaged to support the implementation of two national initiatives to increase mental health support and services to people at risk of, or affected by, disasters. Tuli contributed to this national-scale consultation by supporting interviews, analysing qualitative data, reviewing literature, and drafting findings.

POLICY AND STRATEGY

- Co-design of a theory of change for a cross-sector integrated service initiative in a disadvantaged urban community (2022-2023): In his past role as Project Officer for Transforming early Education and Childhood Health Research Centre (TeEACH), Tuli contributed to the development of a co-designed Theory of Change, an evaluation framework, and other implementation tools on behalf of a service integration initiative comprised of a coalition of government and non-government agencies. The research component of this work included conducting a literature review, facilitating focus groups, and conducting qualitative data analyses.
- Co-design of an integrated intergenerational model of care (Uniting, 2022-2023): In his past role as Project Officer TeEACH, Tuli contributed to the development of a model of care for Uniting Westmead, where an aged care facility and early learning centre are co-located. This involved facilitating focus groups and a co-design workshop, conducting qualitative data analysis, and developing a theory of change and model of care.
